# Minutes of February 5, 2020 Finance Committee Meeting

MR. TULIS ASKED FOR A MOTION TO APPROVE THE FEBRUARY 5, 2020 WESTCHESTER COUNTY HEALTH CARE CORPORATION FINANCE COMMITTEE MEETING MINUTES. MR. SHROFF MOTIONED, SECONDED BY MR. HOCHBERG. THE MOTION CARRIED UNANIMOUSLY.

## Resolution

Management presented a resolution for approval to finance the purchase of certain medical and IT equipment and furniture for WMC facilities through a lease financing arrangement with Insight Investments.

The lease facility is up to \$15.0 million, at an interest rate based on the five-year swap rate plus 3.83% (currently 4.94%), with a not to exceed rate at closing of 6.5%, for a term of sixty (60) months. This \$15.0 million lease facility was included in the approved 2020 Budget.

The lease will provide Insight Investments with a first security interest in the equipment and furniture financed through the Insight Lease. WMC has entered into lease facilities with Insight Leasing in the past.

MR. TULIS ASKED FOR A MOTION TO RECOMMEND TO THE BOARD A RESOLUTION TO ENTER INTO A LEASE WITH INSIGHT INVESTMENTS FOR CERTAIN MEDICAL AND IT EQUIPMENT AND FURNITURE TO THE BOARD. MR. SHROFF MOTIONED, SECONDED BY MR. HOCHBERG. THE MOTION CARRIED UNANIMOUSLY.
