MR. TULIS MOTIONED TO RECOMMEND APPROVAL OF THE RESOLUTION TO THE BOARD AUTHORIZING WMC TO ENTER INTO (i) AN INTERM LINE IN THE AMOUNT OF UP TO \$3 MILLION TO HA; AND (ii) GUARANTEE THE DEBT SERVICE ON SUCH REPLACEMENT LINE OF CREDIT FOR HA, MR. VODOLA SECONDED. THE MOTION CARRIED UNANIMOUSLY.
